Instructions for submission of Call for Quotes

Interested parties are hereby invited to submit their proposals for the purchase of RWI Phonics books (as listed in 1.3).

1.1. Initial Consideration

- 1.1.1. In submitting the bid, the bidder accepts in full and in its entirety, the content of this document, including subsequent clarifications that may be issued by the ST Jean Antide. Bidders are expected to examine carefully and comply with all instructions contained in this document.
- 1.1.2. The objective of this CfQ is to supply ST Jean Antide with a number of phonics decodable books as listed in 1.3.

1.2. Validity and Closing Date

- 1.2.1. No call for quotations shall be considered unless:
 - It is received before the closing date;
 - The quoted prices are to be sent on a different sales quotation addressed to St Joan Antide School Reference KA220-1-MT01-KA220-SCH-000035832.
 - Prices should include i) Unit Price, Net Amount, VAT % and RRP.

A confirmation email shall be sent to bidder upon receipt of email within 3 days of receipt.

- 1.3.2. Any call for quote that is incomplete and/or does not include all of the information required covered may not be considered.
- 1.3.3. Call for quotes shall be valid for six months from the quote's closing date.
- 1.3.4. Bidders shall not retract or withdraw their submitted quotes throughout the adjudication period commencing from the closing date fixed for the presentation of call for quotes. The quotes shall remain binding and may be accepted within such period by ST JEAN ANTIDE.
- 1.3.5 St Jean Antide holds the right to increase the number of books ordered and holds the successful bidder to keep the same prices as per quotation submitted.

1.4 Reservations

- 1.4.1. The St Jean Antide reserves the right to accept, reject or cancel any call for quote, wholly or in part, and to reject all offers without giving any justification whatsoever. The St Jean Antide reserves the right to alter any quantities and/or delete any item/s from the bills of quantities when awarding the contract.
- 1.4.2. The quote itself does not commit or bind St Jean Antide in any manner whatsoever.
- 1.4.3 Should more than one bidder be compliant and offer the cheapest price for a particular book, the latter will be awarded to that bidder who has offered the highest quantity of cheapest priced books.

1.5 Submission and Clarification

- 1.5.1. The successful bidder shall be bound to conform in all aspects with VAT and other fiscal legislation and regulations, and all other regulations, licensees, insurances and guarantees in connection with this call for quotes.
- 1.5.2 Clarifications should reach this Office by not later than **Friday 27**th **August** via email addressed to **Ms Marion Cutajar** head.primary@sja.edu.mt and Christopher Bugeja on Christopher.bugeja@maltadiocese.org.

A receipt of email shall be sent to confirm that clarification has been received.

1.5.3 Submission of quotations should be sent by email to Ms Marion Cutajar head.primary@sja.edu.mt and Christopher Bugeja on Christopher.bugeja@maltadiocese.org.

Late clarification requests will not be entertained, and late submissions will not be accepted.

1.6 Criteria for Award

- 1.6.1 The contract shall be awarded on the following criteria:
 - i) Cheapest overall price for all the items listed (preference shall be given to bids that include all the items).
 - <u>ii)</u> In case there are no legible bids for (i) consideration, quotes shall be considered per book and St Jean Antide holds the right to award cheapest bids of individual books / number of books to different bidders.
- 1.6.2 Should more than one bidder who is compliant and offer the cheapest price for a particular item, the latter will be awarded to that bidder who has offered the <u>highest</u> <u>quantity of cheapest priced books</u>.

1.7 Specific Conditions

- 1.7.1. The service provider is to deliver the resources within a period of 4 weeks from receiving an email confirmation that their bid was the cheapest.
- 1.7.2 The Service Provider will incur a penalty of TEN Euro (€10) for each day of delay and the ST JEAN ANTIDE hold the rights to cancel the order and revert to the second cheapest bid.
- 1.7.3 The books are to be delivered at St Jean Antide School, Gudja.
- 1.7.4 In case the service provider incurs a penalty for late delivery, delivery period must not exceed six (4) weeks from confirmation email.
- 1.7.5 The ST JEAN ANTIDE reserves to right to cancel the supply contract with the service provider should the stipulated delivery period excelled the limits stated above, without prejudice to all rights of the ST JEAN ANTIDE against the Service Provider, including for the payment of the stipulated penalty for delay, without any deduction, and compensation.

1.8 Payment and Time Frames

- 1.8.1 Payment shall be affected within 60 days from the receipt of invoice following the delivery of requested items.
- 1.8.2 Payment shall only be affected after the receipt of invoice following confirmation by the contract authority that all items received are as per requested specifications in the call.
